## Treasurer's Report:

Penny Waltke, Fair Board Treasurer had to print off the financial documents and did not have them ready to hand out during the meeting. Penny Waltke did state the Fair Association has \$18,762.21 in their account as of October 31, 2023

### Election of Directors-

President Keith Bower stated that it is now time to vote for the seven Fair Board Director Positions that are open for the Fair Board. There are 4-3-year terms, 1-2- year term, and 2-1-year terms up for election. The following individuals that are running for one of the seven positions are: Ronnie Bauman, Stacey Bower, Deb Cupp, Shirel Hart, Kristine Kirsch, Bill Lindsley, Mark Trowbridge, Penny Waltke, and Ron Weston. Keith Bower asked each person running for a Fair Board position to stand up and make a short speech before we begin the voting. Everyone stood up and spoke except Ronnie Bauman.

### Roll Call of Membership and Election of Directors-

Keith Bower stated that we will begin the voting for the Fair Board of Directors. Mindy Timm, the Fair Board Secretary, stated that Jackie Brazo and Tabatha Wedge will call each member up by announcing their name. Once your name is announced please proceed to the table where the executive committee is sitting, and you will receive your voter number on a small piece of paper. This voter number you will use for the election of directors and for the voting of by-law changes. Once you receive your voter number you will proceed behind the screen and sit at one of the computers to cast your vote. Amber Johnson and members of the nominating committee will be back behind the wall to help anyone that needs assistance voting on the computers. Roll call and voting began.

## Results of Election for New Fair Board Directors:

122 Fair Association Members voted. The following Fair Association Members were voted on the Fair Board.

- Sheril Hart 54 votes received.
- Ronnie Bauman 51 votes received.

## Proposed By-Law Changes – Policy and By-Law Committee

Jeff Brazo, member of the By-Law Committee stood up and addressed the Fair Association regarding the proposed by-law changes. Jeff Brazo stated that the By-Law Committee put together the working document everyone should have received via email or mail the proposed by-law changes 30 days before this Annual Meeting with the Annual Meeting notice from the Fair Board Secretary, Mindy Timm. Jeff Brazo stated that this document (attached to meeting minutes) is a working document and worksheet during discussion, this is not the ballot, you will vote via computer like you did for the election for Fair Board Directors. Angie Mingus mentioned that each section and item we are voting on has to have 2/3 votes of Fair Association Members present at the time of the start of the meeting to pass. Jeff Brazo started going through the proposed by-law changes. There was open discussion with the Fair Association Members.

After the review of the proposed by-law changes, Mindy Timm, the Fair Board Secretary, stated that we will not be making roll call for this vote. Please step forward and bring your voter identification number with you and proceed behind the wall to vote as we did for the election. Voting for the proposed by-law changes began.

## Results of Election for the Proposed By-Law Changes:

122 Fair Association Members were present and eligible to vote at the beginning of the Fair Association Meeting. Each Article needs to have 2/3 votes to pass. 81votes are needed for something to pass. 103 Fair Association Members voted on the proposed by-law changes.
